PERMISSION TO PARTICIPATE/RELEASE OF LIABILITY AND ASSUMPTION OF RISKS

The undersigned individual(s) desire(s) to use and/or desire their child(ren) to use The Aquatic Club of Brookfield indoor swimming/instructional facility located at 94 Old State Road, Brookfield, CT 06804 ("Facility"). In consideration for the Aquatic Club permitting me or my child(ren) to use the Facility, I have agreed to execute this Permission to Participate/Release of Liability and Assumption of Risks (the "Release"). I hereby acknowledge, accept and agree that the sport of swimming, swim instruction and the use of the pool involve inherent risks. I have examined the pool/facility and have full knowledge of the nature and extent of all the risks associated with recreational swimming/swim instruction and the use of the pool, including, but not limited to: 1.) Drowning 2.) Spinal Injury 3.) Failure to follow the Aquatic Club's employee's instructions or failure to ask for information or assistance. I further acknowledge that the risks listed above is not inclusive of all possible risks associated with the use of the pool and related training and I agree that such list in no way limits the extent or reach of this Permission to Participate/Assumption of Risk, Release and Indemnification. If I see or hear anything that I feel is questionable or dangerous, it is my responsibility to ask or inform the Aquatic Club's employees until corrected or satisfactorily answered. I also agree to release and discharge Kids View, LLC, dba The Aquatic Club of Brookfield ("Aquatic Club") and Whisconier View, INC. and all of its team members, instructors, coaches, officers and employees from and against any and all damages, actions, claims and liabilities, whether known or unknown, anticipated or unanticipated, suspected or unsuspected, relating to or arising from any activity, occurrence, or event involving the pool or the Aquatic Club. This release is intended to release and discharge the Released Parties from all damages, actions, claims and liabilities arising from or related to the negligence of the Released Parties. I further agree to indemnify, hold harmless and defend the Aquatic Club from and against any loss, damage, liability and expense, including costs and attorneys' fees, incurred by the Aquatic Club as a result of my using the Facility or participating in any activity sponsored by or involving the Aquatic Club. I HEREBY VOLUNTARILY WAIVE ANY RIGHT I MAY HAVE TO A TRIAL BY JURY IN ANY ACTION, PROCEEDING OR LITIGATION INVOLVING ANY RELEASED PARTY. If The Aquatic Club of Brookfield should cancel a program, e.g. 3 or less registered for a class, a refund will be issued. **If a participant decided to withdraw from a program prior to and/or after the first class, a credit less a \$35 service charge will be issued.** Credits will not be issued after the second class. Credits may only be used for swim lessons and are valid for one year from the date of being issued. No refunds or credits will be given due to lack of use. **There are no make-up classes or substitute classes if a participant misses a class.** If The Aquatic Club of Brookfield must close the facility due to inclement weather, a make-up class will be arranged. The Aquatic Club of Brookfield reserves the right to remove any participants from the class that are repetitively disruptive to the class. The Aquatic Club of Brookfield reserves the right to close its facilities for special events, renovations, repairs and maintenance. The Aquatic Club of Brookfield reserves the right to adjust any and all fees at any time throughout the year. With notice, class times may be changed. The Aquatic Club of Brookfield reserves the right to use any photograph taken at The Facility, during a lesson (private or group), a birthday party or private group, in the Aquatic Club's promotional materials, brochures and website. **Make-ups will only be provided when the Aquatic Club of Brookfield cancels a class. No Credits will be given in the Summer Program.**
